Zimzala shall inspect all warranty claims. In the event of a defect, ZIMZALA, LLC will repair or replace the defective part or entire item, at its discretion.

The purchaser must, before return of a defective product, obtain an authorization number from Zimzala, LLC. Please write or call to the address or number below.

Once the authorization number is obtained, the purchaser must ship the product back to Zimzala, LLC (at their expense).

This Warranty DOES NOT cover:

- Punctures, cuts, abrasions sustained by improper use or handling, sharp objects, chairs, knives, keys, items involved in accidents, items damaged in whitewater mishaps, or other unreasonable uses and damage caused by improper storage.
